**Proclamation**

WHEREAS, beginning on June 4, 2010, there was an imminent threat to life and property as a result of spring flooding in Idaho, Adams, Valley, Payette, Lewis, Gem and Washington counties caused by heavy rain, and river and stream runoff; and

WHEREAS, above average spring precipitation created this perilous situation; and

WHEREAS, damage to public and private property constituted a significant threat to Idaho, Adams, Valley, Payette, Lewis, Gem and Washington county residents and commerce; and

WHEREAS, there was extreme peril to public safety and property which was likely to be beyond the control of the services of Idaho, Adams, Valley, Payette, Lewis, Gem and Washington county governments;

A disaster was declared to exist by proclamation ID-01-2010, declared on June 8, 2010, amended and extended on June 9, 2010, amended on June 22, 2010, June 23, 2010, and June 28, 2010, and extended on

NOW, THEREFORE, I, C.L. "BUTCH" OTTER, Governor of the State of Idaho, do hereby declare an end to the state of emergency and state of disaster emergency in Idaho effective November 6, 2015.
